WELCOME STATEMENT FROM THE EAERE PRESIDENT



Dear EAERE friends and colleagues,

Welcome to the 29th Annual Conference of the European Association of Environmental and Resource Economists! It is with great pleasure that I welcome every one of you to this year's Conference in Leuven.

This year we received an all-time record of 1,533 submissions: a great success and a clear sign of increasing interest from a community that keeps growing over time. The record number of paper submissions and registrations led us to reach the Annual Conference venue's maximum capacity in early May, an unexpectedly positive result. To allow the widest possible participation and in a continued effort to be more inclusive and accessible, EAERE 2024 includes a rich set of sessions in a hybrid format so that participants can attend them remotely.

I am personally grateful to my colleagues at KU Leuven, Johan Eyckmans and Sandra Rousseau, who accepted the challenge of organising our Annual Conference at a time where hybridisation costs and organisational efforts are still quite demanding.

Our warmest gratitude goes also to Programme Committee co-chairs Enrica De Cian, Johan Eyckmans, Eric Nævdal, and Sandra Rousseau, who together with the Local Scientific Committee – Estelle Cantillon, Simon De Jaeger, Ingrid Molderez, Guido Pepermans, and Stef Proost, and with the important contribution of 357 referees, have prepared a rich scientific programme. Our gratitude goes also to our Association's Secretariat team for its constant and careful work for the execution of the Conference.

Please see our full conference programme which includes 564 accepted papers. The programme consists of plenary sessions, parallel paper sessions, egg-timers, 15 high-level policy sessions, 6 thematic sessions, a welcome reception, an informal social event, a 5K run and a conference dinner. This year we have prepared a variegated and interesting online programme. A rich programme of related events is also available. The programme includes two important association events: the session at which we will announce this year's awards and recognitions, and the General Assembly of Members. We are counting on everyone's participation to applaud and congratulate our outstanding colleagues and to shape our future priorities and strategies together.

EAERE is a growing community, and the interest and enthusiasm towards our activities is shown not only by our research community but also by the policy makers, as reflected in the panels of high-level representatives in our policy sessions. This year we will host a WCEREA coordinated session on Climate Change, Land-Use, and Biodiversity: this session is part of a series of sessions that are run in each of the regional Associations of Environmental and Resource Economists' Annual Conferences, and witnesses the fruitful collaboration which will finally and Resource Economists (WCERE) in 2026.

Thanks to the efforts of our Policy Outreach Committee (POC), the Programme includes an important Policy session that will see the cooperation of our Association with the IPCC and the European Commission to discuss expected content and relevance of the 7th IPCC Assessment Cycle, and potential contributions of environmental economists in the 7th Assessment Report.

Our POC has also worked on the organisation of a Policy Session on Just transition and the challenges of occupational and sectorial reallocation which addresses a particularly key issue for the future of the European climate policy: its capacity to reconcile the urgent need for a rapid ecological transition with the need to leave no one behind.

I would like to thank our Council Members, Carmen Arguedas, Enrica De Cian, Monica Eberle, Phoebe Koundouri, Åsa Löfgren, Linda Nøstbakken and Alessandro Tavoni: together we worked to ensure that this year's Conference meets our Association's high scientific and organisational standards.

I invite you to take part in our General Assembly of Members to be held on July 1st, from 16:00 to 17:30 CEST. Those members who are not attending the conference in person are warmly encouraged to participate online.

I wish you all a great time at EAERE2024.

WELCOME FROM THE LOCAL ORGANISING COMMITTEE

Dear participants from all over the world,

As environmental economists and long-standing members of EAERE and loyal participants in its annual conferences, we felt it was high time to bring the annual EAERE meeting to Belgium and Leuven. We are therefore enthusiastic to welcome all of you in Leuven for EAERE 2024 – the 29th Annual Conference of the European Association of Environmental and Resource Economists!

Belgium and Flanders may be small in terms of area but they are large in terms of universities, R&D, and innovation. KU Leuven university, which celebrates its 600th anniversary in 2025, has a centuries-old tradition of ground-breaking research and high-quality education. The university is growing fast, both in quantity and quality. KU Leuven University is the highest-ranked non-US institution on the Reuters list of most innovative universities. The university town of Leuven lies in the core of Europe, 20 km from Brussels which is a center of international diplomacy, EU decision-making, corporate headquarters, and NGO activity.

Both KU Leuven university and the city of Leuven are focused on sustainability. KU Leuven has made sustainability a core value in recent years by incorporating it deeply into its strategic plans. It offers for example university-wide courses with a sustainability focus, it has integrated sustainability as an important criterion in its operations, and it is regionally, nationally, and internationally active in various networks focusing on sustainability. Likewise, the city of Leuven wants to become a climate-neutral city and is one of the 100 cities chosen by the European Commission for the '100 Climate-Neutral and Smart Cities by 2030' mission.

This year, we received a record number of approximately 1,500 paper submissions, along with many proposals for policy and thematic sessions. The conference venue can accommodate a maximum of 700 participants, a number comparable to the number of participants of the last two EAERE meetings. Because of high demand and limited capacity, registrations for in-person participation had to be closed early. But, in line with the EAERE Council's decision, we are also offering a substantial number of sessions in a hybrid format for our online registered participants. All policy and thematic sessions, as well as the three plenary sessions (which include the keynote speeches, the ERE Editorial Announcements, the Awards Announcements, and the Opening and Closing Sessions of the conference), will be available online.

Meanwhile, we are approaching rapidly the 1.5°C target that humanity put itself in the 2015 Paris Accord. Climate change does not pause. Besides rising temperatures and sea level rise, other environmental problems such as biodiversity loss, and air, water, and soil pollution are not yet fully under control worldwide. Addressing these complex problems requires also environmental economics knowledge and insights. That is exactly what the EAERE conference aims for by bringing together experts to understand the causes of the problems and to find and promote sustainable solutions. We wish you a stimulating conference and many enjoyable moments in Leuven!

Rashid Sumaila is a Professor and Canada Research Chair in Interdisciplinary Ocean and Fisheries Economics at the Institute for the Oceans and Fisheries, and the School of Public Policy and Global Affairs, University of British Columbia. His research focuses on bioeconomics, marine ecosystem valuation and the analysis of global issues such as fisheries subsidies, marine protected areas, illegal fishing, climate change, marine plastic pollution, and oil spills. Dr. Sumaila received his Ph.D. in Economics from the University of Bergen Sumaila is widely published and cited. He won the 2017 Volvo Environment Prize, was co-recipient of the 2023 Tyler Prize for Environmental Achievement and was named a Fellow of the Royal Society of Canada in 2019. His interest in the environment started early in life when his grandfather used to say people should "walk as if the ground feels pain" – this is sophisticated environmentalism! "Long-term Wellbeing and Risks of Abrupt Changes - A Journey"

Anne-Sophie Crépin the deputy director of the Beijer Institute of Ecological Economics and is a member of the Strategic Advisory Committee at the Stockholm Resilience Centre. Her research links scientific theories about the Anthropocene, regime shifts and economic dynamics and aims to answer mainly two broad questions. Firstly, in what way does the interplay between ecosystems and socioeconomic dynamics influence the risk of abrupt changes that could lower human well-being? Secondly, how can society deal with this risk in a way that sustains long-term human well-being? A substantial part of her work is based on small theoretical dynamic models that combine relevant economic factors with complex ecosystem dynamics. Recent publications also include more empirical studies and behavioral experiments. She obtained her Ph.D. in economics from Stockholm University. In 2003 she received the Arnberg Prize from the Royal Swedish Academy of Sciences.
